### **OLD BUSINESS**

#### A. Update for Farr West – Quote for VFD and Upcoming Design Work

An Agreement is being drafted and will be available for signature next week. The current plan is to send out the bid package around December of this year. Award the project in January or February and begin work in the Spring of 2023. On a motion from Director Swartfager and seconded by Director Noack, on a vote of 5 to 0, the Board approved the Agreement between Farr West Engineering and McKinney Water District to Upgrade the Electrical System.

#### **B. Sierra Controls SCADA**

The Proposal has been signed and Bob Rhees will keep the district updated on the progress.

#### A. Treasurer's Report

The Board accepted the Treasurer's Report as presented for the month of January 2022 totaling - \$777,605.06

### B. Bills/Charges and Transfers

The Board reviewed the February 2022 Bills and Charges totaling \$10,144.29. On a motion of Director Swartfager and seconded by Director Noack the bills and charges were approved by a vote of 5 to 0.

# C. Appointment of Board President

Director Arcidiacono nominated Director Swartfager to continue as Board President for the upcoming term. On a Motion by Director Arcidiacono and seconded by Director Noack on a vote of 5 to 0. Director Swartfager was appointed Board President for a term of one year ending February 1, 2023.

## D. Cyber Security Update

Our security systems are monitored constantly and if there is ever an attempted cyberattack on the district's water system. The District Agent will be notified immediately and action will be taken to thwart any outside activity.

## E. El Dorado Savings CD – Maturity Date 3/19/22

The El Dorado Savings Bank CD will mature on 3/19/22. The Board has instructed the Secretary/Treasurer to keep the funds in the El Dorado Savings CD or move the funds into an Umpqua CD depending on the current CD rates.

#### F. District Agent G. Payne – Monthly Report and Water Analysis February 2022

The Secy./Treas. presented the District Agent's Monthly Report. January 2022 Production 567,855 Gallons.

Coliform/Fecal testing per sample site plan came back negative. Samples were taken at 901 McKinney Creek Rd. in McKinney Estates.

The Board has requested price quotes for a natural gas line brought to the property to power a natural gas generator. District Agent Payne will investigate.

The District received a Sanitary Survey from the State Water Resources Control Board. There are several items that need to be addressed. The Board discussed these issues and the Secretary/Treasurer and the District Agent will make sure to correct each item before the deadline.
